LOS ALAMITOS FOOTBALL PLAYER T.A. CUNNINGHAM HAS FILED FOR AN INJUNCTION TO BE ALLOWED TO PLAY STARTING THIS WEEK, ACCORDING TO A COURT FILING THAT ALLEGES THAT THE TOUTED TRANSFER FROM GEORGIA WAS MISLED WHILE PURSUING NIL DEALS.

THE CUNNINGHAM FAMILY, THE FILING ALLEGES, DISCUSSED A "CALIFORNIA PLAN" WITH LEVELS SPORTS TO MOVE TO CALIFORNIA TO SEEK LUCRATIVE NIL DEALS.

THE LEVELS TEAM PROMISED THAT THE CUNNINGHAM FAMILY WOULD HAVE A HOME, TRANSPORTATION AND MEALS IN CALIFORNIA. A PROMISE WAS EVEN MADE THAT THE LEVELS TEAM WOULD PROVIDE A SEPARATE HOME IN GEORGIA FOR (CUNNINGHAM'S) MOTHER.



CUNNINGHAM AND HIS BROTHER WERE GOING TO LIVE WITH A MEMBER OF THE LEVELS TEAM WHEN THEY FIRST MOVED TO THE AREA.

THE LEVELS TEAM WAS TO MARKET CUNNINGHAM TO UNIVERSITY FOOTBALL PROGRAMS' COLLECTIVE GROUPS IN ORDER TO OBTAIN A LUCRATIVE NIL DEAL.

LEVELS PAID FOR (CUNNINGHAM) TO VISIT THE FOLLOWING FOOTBALL PROGRAMS: USC, UCLA, MICHIGAN, MICHIGAN STATE, CENTRAL MICHIGAN, NOTRE DAME, TEXAS AND TEXAS A & M.



CUNNINGHAM, THE FILING STATES, DIDN'T SECURE ANY NIL DEALS.

"(CUNNINGHAM) ASKED THAT HIS CONTRACT WITH LEVELS BE RESCINDED.

LEVELS COMPLIED WITH THIS REQUEST," THE COURT FILING STATES. "(CUNNINGHAM) IS HOMELESS. HE DID NOT RECEIVE THE NIL DEALS THAT WERE PROMISED BY THE LEVELS TEAM. HE HAS BEEN VICTIMIZED."

"THE DESPICABLE ACTIONS OF THE NIL AGENTS SHOULD HAVE BEEN CONSIDERED AS A MITIGATING FACTOR," THE FILING ADDS.

CIF BYLAW 212

A STUDENT DETERMINED BY THEIR RESPECTIVE CIF SECTION TO HAVE VIOLATED ANY PROVISION OF 212.C SHALL BE PENALIZED ACCORDING TO THE SANCTIONS LISTED BELOW:

FIRST VIOLATION

THE STUDENT SHALL RECEIVE A FORMAL WARNING AND RETURN ANY AWARD(S) IN EXCESS OF THE MAXIMUM AMOUNTS ALLOWED IN BYLAW 212; AND/OR AT THE DIRECTION OF THE SECTION IMMEDIATELY REMOVE ANY ADVERTISEMENT, PROMOTIONAL ACTIVITY, OR ENDORSEMENT DEPICTING THE STUDENT'S AFFILIATION WITH THEIR SCHOOL, LEAGUE, CIF SECTION(S), OR THE CIF STATE.



THE STUDENT SHALL BE INELIGIBLE TO
PARTICIPATE IN INTERSCHOLASTIC ATHLETICS
FOR A PERIOD OF ONE YEAR FROM THE DATE
OF CIF'S DETERMINATION OF THE
SECOND VIOLATION.



THE STUDENT SHALL BE BANNED FROM INTERSCHOLASTIC ATHLETICS FOR THE REMAINDER OF THE STUDENT'S ELIGIBILITY.

UNDUE INFLUENCE



WHAT IS UNDUE INFLUENCE!

UNDUE INFLUENCE IS ANY ACT, GESTURE OR COMMUNICATION (INCLUDING ACCEPTING MATERIAL OR FINANCIAL INDUCEMENT TO ATTEND A CIF MEMBER SCHOOL FOR THE PURPOSE OF ENGAGING IN CIF COMPETITION REGARDLESS OF THE SOURCE) WHICH IS PERFORMED PERSONALLY, OR THROUGH ANOTHER, WHICH MAY BE OBJECTIVELY SEEN AS AN INDUCEMENT, OR PART OF A PROCESS OF INDUCING A STUDENT, OR HIS OR HER PARENT(S)/GUARDIAN(S)/CAREGIVER, BY OR ON BEHALF OF, A MEMBER SCHOOL, TO ENROLL IN TRANSFER TO, OR REMAIN IN, A PARTICULAR SCHOOL FOR ATHLETIC PURPOSES.



CIF BYLAW 510 UNDUE INFLUENCE

THE USE OF UNDUE INFLUENCE BY ANY PERSON(S) TO SECURE OR RETAIN A STUDENT OR THEIR PARENT(S)/GUARDIAN(S)/CAREGIVER AS RESIDENTS MAY CAUSE THE STUDENT TO BE INELIGIBLE FOR HIGH SCHOOL ATHLETICS FOR A PERIOD OF ONE YEAR AND SHALL JEOPARDIZE THE STANDING OF THAT HIGH SCHOOL IN THE CIF.



CIF BYLAW 510 UNDUE INFLUENCE

A STUDENT SHALL BECOME INELIGIBLE FOR CIF COMPETITION FOR A PERIOD OF ONE YEAR AND SHALL BE PENALIZED ACCORDING TO **BYLAW 212** FOR ACCEPTING MATERIAL OR FINANCIAL INDUCEMENT TO ATTEND A CIF MEMBER SCHOOL FOR THE PURPOSE OF ENGAGING IN CIF COMPETITION, REGARDLESS OF THE SOURCE. THIS INCLUDES, BUT IS NOT LIMITED TO, STUDENT INDIVIDUAL ENDORSEMENTS THAT INVOLVE ANYONE FROM, OR ASSOCIATED WITH, A SCHOOL OR ITS ATHLETIC PROGRAMS.



WHAT DOES IT MEAN TO BE ASSOCIATED WITH A SCHOOL?

ANY ORGANIZATION OR INDIVIDUAL THAT ASSISTS OR CONSULTS WITH A FAMILY/STUDENT RESULTING IN ENROLLMENT AND/OR RETENTION AT A SPECIFIC SCHOOL FOR FINANCIAL OR ATHLETIC PURPOSES.

PERSONS ASSOCIATED WITH A SCHOOL INCLUDE BUT ARE NOT LIMITED TO:

CURRENT OR FORMER COACHES, CURRENT OR FORMER ATHLETES,

PARENT(S)/GUARDIAN(S)/CAREGIVER OF CURRENT OR FORMER STUDENT/ATHLETES,

BOOSTER CLUB MEMBERS, ALUMNI, SPOUSES OR RELATIVES OF COACHES, TEACHERS AND

OTHER EMPLOYEES, COACHES WHO BECOME EMPLOYED, ACTIVE APPLICANTS FOR COACHING

POSITIONS, AND PERSONS WHO ARE EMPLOYED BY COMPANIES OR ORGANIZATIONS THAT

HAVE DONATED ATHLETIC SUPPLIES, EQUIPMENT OR APPAREL TO THAT SCHOOL.

Developing a plan

- Began by discussing a general framework for what 'we' (staff) thought would be an appropriate set of guidelines to follow.
- After creating this framework, legal team began crafting some specific by-law and Policy language that was reviewed (and overwhelmingly approved) by the membership.
- In general, the intent is to allow students a chance to capitalize on their NIL, assuming certain conditions are met.

IHSA By-law

- Membership modified the current 'Amateurism' by-law to include the following language aimed at NIL activities for students in Illinois:
 - The renumeration shall not be provided as an inducement to attend or remain enrolled at any member school.
 - The renumeration shall not be provided by any member school or an agent of a member school.
 - The renumeration can be for "any NIL activity for which a student in a member school performs any work, service, endorsement, or makes any appearance...as determined by the Board (and) as defined in the Board Policies."

IHSA Board Policy

- In Illinois, NIL Activity is subject to the following limitations:
 - ✓ The student may note use the IHSA name, logos, or trademarks in association with receiving the compensation or imply that the IHSA approves of the NIL Activity as that term is defined.
 - ✓ The student may not use the name, logos, mascots, or trademarks of any member school in association with receiving the compensation or imply that any member school approves of the NIL Activity.
 - ✓ The student may not use any member school's facilities in association with the NIL Activity.

IHSA Board Policy

- In Illinois, NIL Activity is subject to the following limitations:
 - ✓ The student may not engage in NIL Activity during school hours, while traveling to or from any IHSA event, or during an IHSA event (including practice, meeting, or rehearsal).
 - √ The student may note engage in any NIL Activity associated with:
 - 1. Gaming/gambling
 - 2. Alcoholic beverages
 - 3. Tobacco/cannabis
 - 4. Banned/illegal substances
 - 5. Adult entertainment products or services
 - 6. Firearms or other weapons

WHAT IS NAME, IMAGE, AND LIKENESS?

Name, Image and Likeness ("NIL") is defined as the three components of a person's "right of publicity."

On July 1st, 2021 the NCAA permitted student-athletes to be compensated on the basis of their persona rights if there was quid pro quo (something for something) without penalty for the first time in the NCAA's history.

This sweeping change was the first of its kind in collegiate athletics. Currently, the NCAA has adopted interim NIL guidelines and state by state laws vary with some states not having any legislation at all. The long-term expectation is that the federal government will intervene to create some uniform legislation around NIL but there's no exact timeline for this to take place.

Popular NIL engagements include, but are not limited to: social media promotion, endorsements, appearances, autograph signings, camps and clinics, entrepreneurial endeavors, podcasts, radio shows, etc.

Was not specific to HS...but some language still affects the HS market (agents)


The Don'ts

- (1) Adult entertainment products and services;
 - (2) Alcohol products;
- (3) Casinos and gambling, including sports betting, the lottery, and betting in connection with video games, on-line games and mobile devices;
 - (4) Tobacco and electronic smoking products and devices;
 - (5) Opioids and prescription pharmaceuticals;
 - (6) Controlled dangerous substances;
- (7) Weapons, firearms and ammunition.

Protection of PIAA & Member Schools

In engaging in NIL activities, students may not make any reference to PIAA or a PIAA member school (including the school and/or team name, nicknames, terms by which a school or team is commonly referred or identified, logo) and may not wear school uniforms or school-identifying apparel or items).

Amateur Status Rule

PIAA Rules already permitted most NIL considerations.

Use the opportunity to fine tune your rules.

Collectives

"No school or anyone employed by or affiliated with a member school, including booster clubs, coaches, collectives, administrators and alumni, may solicit, arrange, negotiate or pay for a student's, other than their own child, use of their NIL and/or the provision of Consideration to a student for the use of their NIL.


